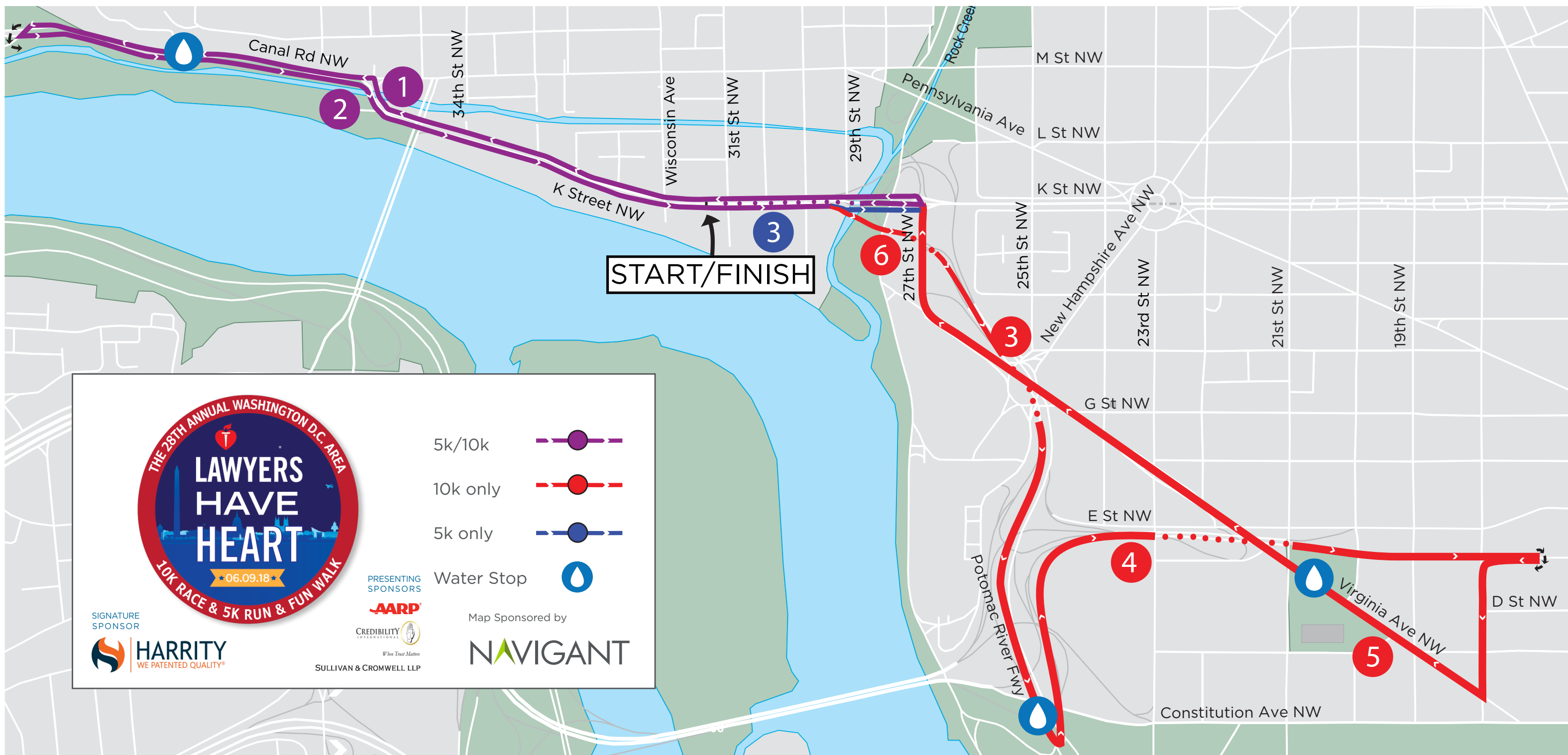

## 10K ROUTE DIRECTIONS

- Make a left onto Whitehurst Freeway toward M Street
- Turn Left onto M Street/Canal Road NW
- U-turn at Canal Road back to Whitehurst Freeway
- Continue on Whitehurst Freeway toward 27th Street
- Bear right on ramp toward Route 66/Potomac River Freeway
- Proceed Southbound on Potomac River Freeway to U-turn
- Take ramp towards E Street Expy
- U-turn on E Street in-between 18th Street and 17th Street
- Continue on E Street toward 18th Street
- Turn left on 18th Street
- Right turn on Virginia Avenue
- Right turn on 27th Street
- Turn left on K Street
- Continue on K Street/Water Street to Finish
- **Finish:** K Street near 31st Street

## 5K ROUTE DIRECTIONS

- **Start:** K Street near 31st Street
- Travel Eastbound on K Street to 27th Street
- Make a left onto Whitehurst Freeway toward M Street
- Turn Left onto M Street/Canal Road NW
- U-turn at Canal Road back to Whitehurst Freeway
- Turn Right onto Whitehurst Freeway
- Take ramp at end of Whitehurst back onto K Street/Water Street
- Continue on Water Street to Finish Line
- **Finish:** K Street near 31st Street
